1. Background

- 1.01. CPA UK and CPA Canada have a long history of facilitating successful thematic parliamentary bilateral delegations on behalf of their respective parliaments.
- 1.02. Following the reconstitution of the Canadian Federal Parliament after the November 2015 General Election, a delegation of Canadian Parliamentarians visited Westminster from 14-15 March 2016 to solidify ties between both the UK Parliament and the Canadian Parliament, as well as Commonwealth organisations and institutions based in the UK. This was especially relevant in light of the appointment of the new Secretary General of the Commonwealth, the Rt Hon. Baroness Scotland of Asthal QC, in November 2015 and of the Commonwealth Parliamentary Association, Akbar Khan, in October 2015.

2. Objectives

Through meetings, discussions and briefings with both Parliamentary and Commonwealth colleagues in the UK the programme focussed on the following objectives:

- 2.01. Issues of mutual interest with counterparts from the UK parliament
- 2.02. The Restoration and Renewal of the UK Parliament
- 2.03. The Role of Backbench Members, the Backbench Business Committee and the Petitions Committee
- 2.04. The Role of the Parliamentary Office for Science and Technology
- 2.05. Issues of mutual interest with Hon. Speaker Dr Shirin Sharmin Chaudhury MP, Chairperson of the CPA International Executive Committee and Akhbar Khan, CPA Secretary General
- 2.06. Issues of mutual interest with the Rt. Hon Baroness Scotland of Asthal QC, Commonwealth Secretary General Designate

4. Summary

4.01. Executive Summary

4.01.1. The visit, which took place over the course of two days (Monday 14 March 2016 - Tuesday 15 March 2016), helped solidify ties between the UK Parliament and the Canadian Federal Parliament, as well as with Commonwealth organisations based in the UK. Through various meetings and discussions, the delegation gained a greater understanding of recent changes to parliamentary procedure in the UK, such as the establishment of the Backbench Business Select Committee in 2010 and the Petitions Select Committee in 2015, along with an insight into current political issues in the UK and the Commonwealth. There was also a constructive exchange of good practice between UK and Canadian Parliamentarians with regards to their respective parliamentary renovation projects, as well as between the Canadian delegation and the UK Parliament's Office for Science and Technology (POST).

4.02. An Insight into the UK Context

- 4.02.1. As Monday 14th March 2016 was Commonwealth Observance Day, the delegation were able to attend the Service in Westminster Abbey. This year's theme was 'A Young Commonwealth', recognising the contribution and potential of young people across the Commonwealth. Following the service, the delegation met with Diana Johnson MP, Shadow Minister for the Foreign and Commonwealth Office. This was an opportunity for the delegation to get an insight into the current UK political scene, with Ms Johnson focussing on areas such as the upcoming EU Referendum on 23rd June 2016, the UK economy and the UK political parties. This meeting successfully set the scene for the meetings that followed on Tuesday 15th March.
- 4.02.2. The delegation also met with Members from the British-Canada All-Party Parliamentary Group. The UK political context was once more discussed, as was the importance of maintaining the healthy relationship enjoyed between the UK Parliament and the Canadian Parliament.
- 4.03. Utilising Science and Technology in Parliament
- 4.03.1. The delegation met with Dr Chandrika Nath, Deputy Head of the Parliamentary Office for Science and Technology (POST). Dr Nath highlighted the differentiation between the work carried out by POST and other parliamentary offices, such as the Library or Committee Specialists. POST's research is unique in that it can be more proactive in the research it undertakes as it is not determined by requests from Committees or individual Members, like other research outputs might be. It is therefore able to be independent and objective in the research areas it chooses to focus on. POST can then determine gaps in current research and pre-empt issues which are likely to receive parliamentary attention.
- 4.03.2. Given that there is no current equivalent to POST in the Canadian Parliament, this session was of great interest to the delegation. Dr Nath described how each legislature adopts a different system depending on its context and priorities. The delegation were then interested in the practicalities involved in creating an office like POST, in terms of both the level of funding required and the timescale required to set up the Office in the UK Parliament following pressure from Members. Whilst it has been suggested





that a Parliamentary Science Officer position might be created in Canada, it still needs to be determined as to whether or not this Officer will serve only the Government or if the Canadian Parliament will also be able to utilise their services.

4.04. The Restoration & Renewal of Parliament

4.04.1. The meeting with Members of the Joint Committee on the Palace of Westminster proved to be a successful exchange of knowledge and good practice in terms of both the UK and Canadian parliamentary renovation projects. The Canadian Federal Parliament began its renovation project in 2001 and so the delegation had a great deal of advice to offer the Joint Committee Members. The discussion was led by Baroness Stowell of Beeston MBE, Leader of the House of Lords, and Chris Bryant MP, Shadow Leader of the House of Commons. Also in attendance was Rt Hon. Lord Wallace of Tankerness, Leader of the Liberal Democrats in the House of Lords, and Rt Hon. Lord Laming CBE DL, Chairman of Committees in the House of Lords.

4.04.2. The discussions focussed on the Canadian experiences of moving Members out of their Parliamentary offices and the length of time which these renovations were taking. The financial impact of renovations was also discussed, as was how best to portray the renovations of Parliament as a worthwhile public expenditure to the media and the general public. As a result of the conversation on the Canadian experience of Parliamentary renovations and the importance of public opinion, Chris Bryant MP noted that the renovation of the House of Lords might be more challenged by the public than the House of Commons' renovation, given the debate over the recent years on the role of the Upper House. Both the UK Parliamentarians and the Canadian Parliamentarians agreed upon the need to preserve their respective Parliaments, especially given the history of the buildings, but agreed that there was generally more supportive public opinion in Canada than in the UK, as well as Members who were more willing to move out of their parliamentary offices.

4.05. The Role of Backbench MPs in the UK's Committees

4.05.1. One of the main focusses of the visit was the role of backbench MPs, which was contextualised through meetings with Members of the Backbench Business Committee, Gavin Newlands MP and Bob Blackman MP. Mr Newlands discussed the creation of the Committee and its main functions, highlighting the importance of the independence of the Committee and the parliamentary business hours being used more effectively. Mr Blackman built upon these points, describing how important it was for the Committee to then fill all of the hours which had been allocated so as not to undermine the importance of backbench business. This session was of great interest to the delegation as backbench business in the Canadian Parliament is decided by the Speaker through consultation with the Party Whips. Mr Blackman went on to note the work of 1922 Committee, which represents backbench MPs from the Conservative Party. The Westminster Hall debates were also of great interest to the delegation, given that this second Chamber is so often used for backbench business and, again, no such equivalent exists in the Canadian Parliament.





4.05.2. The focus on the role of backbench MPs was built upon through a meeting with the Chair of the Petitions Committee, Helen Jones MP, and Ian Blackford MP, a Member of the Committee. The Committee, even though it was only established in late 2015, has already carried out their first inquiry into brain tumour research. This was the direct result of an e-petition which had been launched. A recurring question throughout the meeting was how MPs can remain objective when deciding what is suitable or not suitable to table for debate. It was shown that, as long as there was nothing offensive about a petitions content, a petition with a sufficient number of signatories would always be responded to adequately. Ms Jones supported this system as it allows for issues which would not otherwise reach the floor of the house to be considered in Parliament. This meeting allowed for an exchange of good practice between UK Parliamentarians and Canadian Parliamentarians in terms of how petitions and e-petitions are dealt with by the respective Parliaments.

4.06. Canada & the Commonwealth

4.06.1. The delegation also met with the new Secretary General of the Commonwealth, the Rt Hon. Baroness Scotland of Asthal QC, to discuss upcoming challenges in the Commonwealth and the outcomes of the Commonwealth Heads of Government Meeting in November 2015. As the delegation was travelling to Malta following their visit to Westminster, these discussions would be built upon. They also met with the new Secretary General of the Commonwealth Parliamentary Association, Akhbar Khan, and the Chairperson of the CPA International Executive Community, Hon. Speaker Dr Shirin Sharmin Chaudhury MP.

4.07. The Role of Crossbench Peers

4.07.1. Senator Claude Carignan also held several private meetings with relevant UK counterparts in his capacity as Leader of the Opposition in the Senate. In 2014 the Liberal Party introduced changes which saw Liberal Senators now sitting as Independents and no longer a part of the Liberal Caucus. This reform was carried out in an attempt to reduce the partisanship of the Senate. A consequence of this reform has been an inevitable increase in the number of Independent Senators, the practicalities of which, Senator Carignan, as Leader of the Opposition, wished to explore during his time in Westminster. Senator Carigan met with Rt Hon. Lord Hope of Craighead KT, Convenor of the Crossbench Peers, and Baroness Stowell of Beeston MBE to discuss good practice in both the UK House of Lords and the Canadian Senate.

6. Outcomes & Follow-Up

- 6.01. Following the programme, Dr Nath, Deputy Director of the Parliamentary Office for Science and Technology, intends to have follow-up discussions with the Canadian Parliament. The delegation were particularly keen to engage with Dr Nath and POST to discuss how similar services could be provided in the Canadian Parliament. CPA UK will help facilitate these meetings between the Canadian Parliament and POST.
- 6.02. CPA UK will be running a Bilateral Visit to Ottawa in FY 2016/2017 to meet with CPA Canada and relevant counterparts in the Canadian Federal Parliament. Outcomes of the programme will be discussed in greater detail and assessed, particularly with regards to backbench MPs and the convening of Crossbench Senators. The visit to Malta, which immediately followed the Westminster programme, will also be discussed in further detail.
