IMPACT & OUTCOMES

Impact:

The National Assembly of The Gambia is effective, accountable, and inclusive in its delivery of parliamentary business, with National Assembly Members equipped and confident to undertake their responsibilities efficiently.

Outcomes:

Through a programme of meetings, briefings, plenary sessions, and interactive discussions, the programme will deliver the following:

1. Participants have deepened their understanding of parliamentary procedure and are confident in participating effectively in parliamentary business.

PROGRAMME OVERVIEW

From 13-16 June 2022, CPA UK partnered with the Westminster Foundation for Democracy (WFD) to deliver a Post-Election Seminar at the National Assembly of The Gambia. The seminar was attended by 49 National Assembly Members (NAMs), as well as 19 clerks and support staff.

With 36 of 58 NAMs newly elected in the April 2022 parliamentary elections, this programme presented a valuable opportunity to support the NAMs' induction for their new roles and renew the longstanding partnership between the UK Parliament, WFD, and the National Assembly.

The new chapter in this relationship was marked by the signing of a new Memorandum of Understanding between these three stakeholders, ensuring continued collaboration on capacity building programmes for the National Assembly until 2025.

2. Participants have deepened their understanding of committee work and the responsibilities of committee chairs and Members.

3. The links between the UK Parliament and the National Assembly of the Gambia are further strengthened.

Outputs:

1. At least 25 newly elected NAMs participate in the fourday programme.

2. At least 25 participants report increased understanding of parliamentary procedure, including around committee work, and the responsibilities of parliamentarians.

3. A comprehensive outcome report to be produced and disseminated to participants.

EFFECTIVE COMMITTEE SCRUTINY

The National Assembly's committee system reflects that of Westminster, with some differences in scope and levels of resourcing. UK select committees typically have multiple clerks attached to them, alongside a specialist. In The Gambia, 11 clerks work across 26 committees. The National Assembly's committee sessions will often overlap, and so both **clerks and NAMs who serve across multiple committees have to prioritise which sessions they attend**.

This, coupled with the recent high turnover of Members within committees following the recent legislative elections, has meant that provision of informative briefing materials has been essential to delivering effective committee work. Gambian clerks noted they had produced written overviews of the key issues and priorities for each committee at the conclusion of the previous National Assembly session to strengthen the knowledge and understanding of new committee members following the election.







Participants also considered how to effectively pose questions in a committee setting. UK delegates suggested that parliamentarians avoid confrontational 'headline grabbing' questions, arguing that showing respect for witnesses and their expertise tends to yield the most constructive answers. In addition, they emphasised the importance of specific and direct questioning, demonstrating this by challenging NAMs to draft hypothetical questions to a minister with a length of 20 words or less, beginning with the words 'how' 'why' or 'what'.

ENGAGING WITH CONSTITUENTS

Following the recent legislative elections, the question of how to manage constituent expectations was at the forefront of discussions. Acknowledging that it is not always within the power of an individual parliamentarian to implement a policy, Members agreed that it was better to **publicly promise to act as advocates for policies within the National Assembly**, avoiding the risk of "overpromising and underdelivering", and enabling the building of trust with constituents. UK delegates highlighted methods that are within the power of a Member to ensure constituent voices are heard, for example by raising issues of concern in letters to government ministers.

CPA UK IN THE REGION

Uganda: Mentorship Programme for Women Parliamentarians

CPA UK has partnered with the Ugandan Women's Parliamentary Association (UWOPA), UN Women Uganda, and the Westminster Foundation for Democracy (WFD) to deliver a remote mentorship programme that will see parliamentarians from the UK act as mentors to their female counterparts in Uganda through a series of virtual meetings from September to November 2022.

Uganda: Legislative Benchmarking Visit on Legal Aid

CPA UK hosted a delegation of parliamentarians and officials from the Parliament of Uganda in Westminster for a legislation benchmarking exercise focusing on legal aid provision in July 2022. The programme was designed to support delegates' upcoming legislative scrutiny work on the National Legal Aid Bill, using UK legislation for comparative analysis.





The seminar also discussed means of communications between Members and their constituents. Whilst NAMs use social media and other online tools, poor internet coverage in rural areas means these tools have a more limited reach than in the UK. Instead, local committees at a town and village level are used as a key means of disseminating information to constituents.

UK Members discussed their own strategies for constituency communication, drawing particular attention to activities that do not require significant resources or technology, such as holding constituency surgeries, setting up stalls in areas of high footfall, and using a parliamentary letterhead to lend gravitas to their communications when resolving constituency casework.

EMERGENCY SCRUTINY

In the wake of the COVID-19 pandemic and the resulting state of emergency that was implemented in The Gambia, the role of the National Assembly in preventing abuse of executive power during times of crisis became a key topic of conversation.

The power to declare a state of emergency rests with the President. However, this cannot be implemented unless an act of the National Assembly is passed to enforce it. A panellist suggested this **power to legislate to enforce a state of emergency can be used as crucial leverage to curb executive power** when negotiating with the government.

Increased training for committees was also identified as a means for the National Assembly to achieve more effective and indepth scrutiny of emergency powers and their application.

DIVERSE REPRESENTATION

Women are underrepresented in the National Assembly. Of the 246 candidates in the 2022 elections, only 19 were women. There are only five female NAMs serving in the National Assembly, three of whom are elected Members, an additional two having been nominated by President Barrow.

Discussing how to improve female representation in the Assembly, **participants raised the example of the successful 'Not Too Young To Run' campaign.** Inspired by a similar initiative to lower the minimum age for elected office in Nigeria, this campaign brought together young people, political parties, NGOs, and civil society to successfully increase youth participation and representation in Gambian politics. NAMs suggested that this initiative could provide an effective blueprint for the promotion of greater gender diversity within the National Assembly.

MANAGING CONFLICTS OF INTEREST

Participants actively discussed how to best uphold high levels of ethics and standards within the National Assembly. Members accepted their responsibility to declare personal gifts donated to them by outside interests. However, they also expressed a desire for clearer guidance on how to differentiate these gifts from items and services that enable them to perform their duties as parliamentarians.

A recent controversy over a Gambian Member using their parliamentary allowance to purchase clothes was cited as an example of where this distinction can become unclear. In these cases, it was suggested that Members should use their public platforms to justify their spending choices to constituents, and explain why a donation will enable them to be a more effective parliamentarian.

When discussing their own experiences of this subject, UK Members raised the UK Parliament's **register of interests as a vital tool for parliamentarians to declare any potential conflicts** that may be considered to influence their actions as a parliamentarian. UK Members noted that this register serves as a valuable means of protecting parliamentarians from controversy by ensuring a high degree of transparency with the public, and subsequently shared this document with delegates to demonstrate how declarations are listed.

CPA UK IN THE REGION

Webinar on Regional Trade and Parliamentary Scrutiny in Africa

Building on the success of the Africa Regional Workshop on Trade, Security & Gender in January 2022, CPA UK organised a Webinar for Members and Clerks in the Africa region to examine the role of parliamentary scrutiny in the construction and workings of trade agreements, with a particular focus given to the recently created African Continental Free Trade Area (AfCFTA).

Africa Regional Workshop on Trade, Security & Gender

CPA UK delivered a regional workshop with African Commonwealth parliaments in January 2022. The workshop was hosted by the Parliament of Ghana in Accra, and explored how parliaments address trade, gender, and security issues when pandemics and other unexpected external events occur.






FEEDBACK AND NEXT STEPS

FEEDBACK

Participants completed pre- and post-seminar assessment forms to rate their understanding of the topics covered in the seminar, selecting from four options, ranging from 'none' to 'in-depth. Participants also answered questions about how they will apply learnings from the seminar, and in which areas they would like to deepen their knowledge in future.

- Delegates recorded increases in knowledge across all topics. The largest increase was recorded for conducting effective committee work. This reflected the in-person feedback that delegates provided at the close of the seminar.
- Budget and financial was the most frequently mentioned area when delegates were asked to identify where they wished to deepen their knowledge in future, indicating the expansive nature of this topic.
- Engaging with the media and the public was frequently mentioned as a topic where delegates would apply learning from the seminar, suggesting that sessions focused on this topic produced the most practical lessons for implementation.

The following statements are examples of participants' responses to questions posed in the post-assessment form completed at the end of the seminar:

Why was the programme relevant to your role?

"I am a principal clerk for up to five committees. I used to be overwhelmed, and have learnt new ways of strategising and balancing my activities."

How will you apply the learning gained from this programme?

"By having constant consultation with my constituency and Gambia at large, knowing their problems and bringing them to the parliament in order to get them connected to solutions."

What areas do you wish to deepen your knowledge of following this programme?

"I became more enlightened on budget scrutiny - a key area of importance to me as a legislator. I hope more training will be organised to deepen my knowledge in this area."

NEXT STEPS

CPA UK and WFD look forward to continued collaboration with the National Assembly of The Gambia under the new Memorandum of Understanding, which was signed by representatives of these three organisations during the seminar. Participants' feedback on the Post-Election Seminar will inform the design and planning of future activities and ensure to include most-requested topics such as financial scrutiny and media engagement.

Other salient issues that that will be explored in future programmes include strategies to enhance women's representation, and approaches to curbing human trafficking. CPA UK will also continue to engage with the National Assembly through the multilateral programmes it regularly runs with legislatures throughout the Commonwealth.
