



A supply chain represents the journey a product makes from being a raw material in a field, mine or farm to the shop it is sold in. Each link in the chain represents a product's state change during manufacture and production, as well as its physical movement between stages. Each link presents a risk for human exploitation. Globalisation has enabled companies to access materials and production methods around the world, and with it, the workers necessary to complete each stage of the supply chain. Yet it has also made it infinitely harder to trace and monitor these complex supply chains and to know within which labour conditions workers had to work to make the product. This session will provide key information on how human trafficking and exploitation manifest in supply chains.

## Session 5: Mandatory human rights due diligence: Realising the duty of care to workers by managing supply chains responsibly in the private and public sector

Format: Plenary and facilitated discussion

The unanimous endorsement of the Guiding Principles on Business and Human Rights by the United Nations Human Rights Council in 2011 represented a watershed moment in efforts to tackle adverse impacts on people resulting from globalisation and business activity in all sectors. The principles provided, for the first time, a globally recognised and authoritative framework for the respective duties and responsibilities of governments and business enterprises to prevent and address such impacts. It clarifies that all business enterprises have an independent responsibility to respect human rights, and that to do so, they are required to exercise human rights due diligence to identify, prevent, mitigate, and account for how they address impacts on human rights. A growing number of investors are starting to ask enterprises how they manage their risks to human rights. And more and more corporations express their commitments to respect human rights by developing practices that involve ongoing learning, innovation, and initiative. The audience will hear from companies that are taking the rights steps to address the issue at a systemic level.

Hon. Dr. Otiende Amollo, SC, EBS, MP Member, National Assembly of Kenya

Hon. Dr. Otiende Amollo, a Senior Counsel and Advocate of the High Court of Kenya, is a Notary Public, accredited Mediator, Commissioner for Oaths, and Certified Public Secretary. He holds an LL.B (Hons) degree from the University of Nairobi and an LL.M (Public Law) degree from the same University. He has a Diploma and Certificate in Human Rights & Humanitarian Law from the Kenya School of Law and Lund University. Dr. Amollo has been involved in numerous Human Rights and Constitutional Law discourses in Kenya and abroad for the past two decades. He has also undertaken consultancies in developing national legislation on land, insurance, HIV legislation, labour relations, and environmental laws. He has been awarded numerous awards, including the Antony Dzuya Leadership Award and the Honour of Elder of the Burning Spear (EBS) of the Republic of Kenya. Dr. Amollo served as Secretary of the Task Force and key drafter of the HIV and AIDS Control and Management Act.

## Rt Hon. Karen Bradley MP Member. House of Commons. UK Parliament

Since being elected for her home seat of Staffordshire Moorlands in 2010, Karen has been honoured to have served as a Minister in the Government Whips office, a Lord Commissioner of HM Treasury (a senior Whip), the Minister for Modern Slavery and Organised Crime in the Home Office where she brought in the Serious Crime Act to help protect people in the UK from organised crime and just before Parliament was dissolved in March 2015 she secured the passing of the Modern Slavery Act. This was a landmark piece of legislation that protects people from the evil of slavery today. After being re-elected in 2015, she became Minister for Preventing Abuse, Exploitation and Crime at the Home Office followed by Secretary of State for Digital, Culture Media and Sport and then Secretary of State for Northern Ireland until July 2019. In February 2020 Karen was elected Chair of the House of Commons Procedure Committee. She is also Co-Chair of the All Party Parliamentary Group (APPG) on Human Trafficking and Modern Slavery and a trustee of the Human Trafficking Foundation. In November 2022 Karen was elected as Chair of the British Group Inter-Parliamentary Union.



## Rt Hon. Baroness Butler-Sloss, GBE Peer, House of Lords, UK Parliament

Baroness Elizabeth Butler-Sloss GBE was appointed to the House of Lords as an independent peer in 2006. She is Visitor to and Hon Fellow of St Hilda's College Oxford and Hon Fellow of Peterhouse and Corpus Christi Colleges, Cambridge and King's College, London and of several medical colleges. She chaired the Commission advising on the appointment of the Archbishop of Canterbury in 2002 and was chairman of the Security Commission. Lady Butler-Sloss is Chairman of the National Commission on Forced Marriage (NCFM) and former Chairman of the Commission on Religion and Belief in Modern-Day Britain and Chairman of Visitation of Exeter Cathedral. She is co-chairman of the All-Party Parliamentary Group on Modern Day Slavery and Human Trafficking, a Trustee of the Human Trafficking Foundation and a former member of the Anti-Slavery Commissioner's Advisory Panel and of The Westminster Abbey Advisory Panel. She currently chairs the Ecclesiastical Committee (a statutory Parliamentary Joint Committee) and in 2023 became a member of the Procedure and Privileges Committee.

Inspired by her mother, Josephine has championed against female genital mutilation (FGM), Beading and Child Marriage, which are still rampant in her native Samburu community. In pursuit of her vision to empower the Pastoralist girl child, Josephine has rescued over 2,000 girls and through her organisation has provided education; from preschool to tertiary levels. Her boldness to defy century old traditions has been recognised widely, receiving numerous awards including: Unsung Hero 2011, Head of State Commendation 2012, COVAW champion 2013, Acumen East Africa Fellow 2013, UN Person of the Year 2013, Inspiring Woman by Gender commission Kenya 2014, YALI Washington Fellow 2014, Spark Change maker 2015, Vital Voices Lead Program 2015, African Union Youth Hero 2015, Egerton gender award 2015, Gender Equality award 2016, Top 40 under 40 women award 2016, Humanitarian Award 2017, Voice for Girls award 2018, and she was celebrated as one of the top 100 global gender champions in 2019 and 2021, The Anti-FGM Champion and Advocacy award, and in 2022 she received the justice for women award from the Clooney Foundation for Justice. Notably, in his visit to Kenya in 2015, Former US President, Barack Obama lauded her for unparalleled contribution to the protection and development of the girl-child through education. Josephine is relentless in her quest to see children enjoying their full rights, and the eradication of harmful practices for a prosperous Kenya and Africa as a whole.

# Rt Hon. Dame Maria Miller MP Member, House of Commons, UK Parliament



Maria was born in Wolverhampton on 26 March 1964. Educated at Brynteg Comprehensive, Bridgend, South Wales, Maria went on to study at London School of Economics. Maria was first elected to represent Basingstoke in the 2005 General Election. Before entering Parliament, Maria worked for 20 years in marketing, including board level experience, and appreciates some of the pressures faced by working parents. On becoming a Member of Parliament, Maria was appointed to the Trade and Industry Select Committee. David Cameron appointed her as Shadow Minister for Education in December 2005, then Shadow Minister for Family Welfare in the Department for Work and Pensions in November 2006. Maria moved back to the Education team as Shadow Minister for the Family in July 2007 and remained in post until the 2010 General Election. Maria was appointed Minister for Disabled People at the Department for Work and Pensions in the Coalition Government in May 2010 and was promoted to Secretary of State for Culture, Media and Sport, and Minister for Women and Equalities, from September 2012 to April 2014. In June 2015 Maria was elected as Chair of the newly established Women and Equalities Select Committee. Maria was nominated for the position by MPs across the House in 2017 and was re-elected unopposed.
