Strengthening Parliamentary Action to Address Gender-Based Violence and Modern Slavery in Supply Chains, Parliament of Kenya

Celebrating 75 Years of the Modern Commonwealth

In March CPA UK celebrated Commonwealth Day and the 75th anniversary of the signing of the London Declaration, which marks the creation of the modern Commonwealth, with a ceremony in Portcullis House.

Organised by our co-President, Mr Speaker Sir Lindsay Hoyle MP, the event was attended by Speakers and representatives from across the Commonwealth, featuring a flag-raising ceremony and procession – in which CPA UK colleagues took part - and performances of traditional music and dance from Kenya.

It was a unique opportunity to observe the diversity and scope of the Commonwealth, assembled in one space for a common purpose, with representatives from legislatures as diverse as the Falkland Islands, Canada, Sri Lanka, Kenya, and Grenada in attendance.

Strengthening Parliamentary Democracy

Commonwealth Day also coincided with the start of the 72nd Westminster Seminar, our annual flagship programme, which brings parliamentarians from across the Commonwealth together to share their experiences and discuss democratic practices, procedure and parliamentary accountability.

This year sixty-four delegates joined, representing every region of the CPA. After attending the Commonwealth 75th anniversary celebrations they took part in five days of interactive discussions on topics ranging from the role of the Speaker to holding the Executive to account to addressing gendered challenges in elections.



Delegates from smaller and devolved legislatures travelled to Cardiff at the end of the week to meet fellow parliamentarians from the Senedd.

The 2024 Westminster Seminar on Effective Parliaments was welcomed as an opportunity for colleagues to meet for the first time, providing a space for peer-to-peer learning to enhance their roles and further build on their understanding of the Westminster parliamentary system.



Post-Election Seminars

Providing support for newly-elected members, particularly in parliaments without formal induction programmes, is a key means by which we assist the building of stronger democracies.

Sierra Leone & Lesotho

This year we delivered successful Post-Election Seminars for new members in Sierra Leone and Lesotho. In both places, UK parliamentarians discussed with their hosts parliamentary practice and process. All delegates shared their experiences and discussed the challenges faced working as a legislator, and considered ways those can be overcome.







Linking Westminster with the Commonwealth

Parliamentary strengthening was an important topic in a series of bilateral programmes designed to build stronger relationships with key partner legislatures.

Ghana

In April Rt. Hon. Alban Kingsford Bagbin MP, Speaker of the Parliament of Ghana, visited Westminster and met UK parliamentarians, including the Speaker, to discuss parliamentary procedure, accountability through committees, and ministerial obligations and responsibilities.



Namibia

In December we organised a programme focusing on parliamentary procedure, member conduct and committees for eighteen Namibian parliamentarians from both the National Assembly and National Council

Fiji

We hosted a group of clerks from Fiji to explore how the UK Parliament conducts committee inquiries.



Elections

Since 2011, in our role as secretariat for CPA's British Islands and Mediterranean Region (CPA BIMR), we have delivered nineteen election observation missions (EOMs) to UK Overseas Territories and Crown Dependencies.

Over the last year, to assess the impact of our election work, we commissioned an independent report from two Academic Fellows, Dr Matthew Bishop (University of Sheffield) and Professor Jack Corbett (Monash University).



Having shadowed CPA BIMR Election Observation Missions and interviewed a range of stakeholders from across the Overseas Territories and Crown Dependencies, the Fellows concluded that: "the main finding is that these missions are overwhelmingly valuable and effective," whilst offering a set of valuable recommendations for future missions.

In March 2024, we held the report launch where UK parliamentarians and other stakeholders were able to question Dr Bishop about his and Professor Corbett's findings and recommendations.

Elections

Our election observation work continued with a mission to the British Virgin Islands general elections in April 2023. The observers concluded that the British Virgin Islands Election Day was orderly, peaceful and well-run, voting on Advance Polling Day proceeded smoothly, and that the legal framework in place offers a sound basis for democratic elections, whilst also highlighting the lack of progress on campaign financing reform.



In Westminster we ran a course for parliamentarians in the CPA British Islands and Mediterranean Region, to increase participants' understanding of the process of election observation, the role of election observers and CPA BIMR Election Observation Missions.



UK Overseas Territories Project

The UK Overseas Territories Project focuses on enhancing good governance and oversight of public finances across UK Overseas Territories, and is funded by the Foreign, Commonwealth and Development Office.

UK Overseas Clerk Leadership Group Workshop

This year we hosted the UK Overseas Clerk Leadership Group Workshop in partnership with Tynwald in the Isle of Man, with clerks from Anguilla, British Virgin Islands, Cayman Islands, Falklands Islands, Montserrat, St Helena and Turks and Caicos participating in a week-long programme.

Public Accounts Committee Clerk Attachments

In addition, we hosted a delegation of the Public Accounts Committee of the Turks and Caicos Islands for a four-day visit, and facilitated clerk attachments between Tynwald and Montserrat, and the Falkland Islands and St Helena.

Regional and Pan-Commonwealth Events

A delegation of UK parliamentarians represented CPA UK at the 2023 Commonwealth Parliamentary Conference held in Accra, Ghana, in October 2023. They were led by CPA UK Chair Dame Maria Miller MP, with representatives from the three largest parties plus a cross-bench Peer.

The Conference was opened by the President of the Republic of Ghana HE Nana Addo Dankwa Akufo-Addo, who urged Commonwealth parliamentarians to mark the 10th Anniversary of the Commonwealth Charter by recommitting to its values and principles.

CPA UK's delegates participated busy programme workshops covering a range of topics. Rt Hon. Karen Bradley MΡ chaired а lively and interactive youth roundtable at the Parliament of Ghana on the role of the Commonwealth in international security and peacebuilding.



CPA UK delegates also made important contributions to workshops on gender quotas in Parliament and on the Commonwealth Charter and its commitment to protecting human rights.

The Conference was preceded by governance meetings, at which the key issue of CPA's legal status was at the centre of deliberations.

Human rights were central topics of discussion. During a series of meetings, the UK delegation unanimously asserted its commitment to fundamental human rights and equalities as set out in the Commonwealth Charter, which meant that no one should ever be treated differently regardless of gender, sexuality, race, religion, political belief or other characteristic.

British Islands and Mediterranean Regional Conference

The 52nd British Islands and Mediterranean Region Conference on Inclusive and Sustainable Parliaments welcomed over forty delegates from across the region to Westminster in April 2023.

Held in the UK Parliament, the programme brought together several themes on which regional parliamentarians had been working over recent years. This included taking part in a committee hearing exercise on meeting climate change commitments, to highlight good practice in parliamentary scrutiny.

Hearing from experts and parliamentarians from across the region, delegates discussed the importance of diverse and inclusive parliaments and the role they play in strengthening democracy through broader representation and providing a platform for a diversity of views and lived experiences. Standards and behaviour were key topics, and delegates learned about how different legislatures apply and monitor codes of conduct, and registers of interests.



Youth Engagement

2023 was the Commonwealth year of youth, reflecting the fact that over 60% of the Commonwealth's population of 2.5 billion are under thirty years old.

In this spirit, we organised and hosted an interactive Youth Engagement in Parliament event for young people across the UK, designed to inform them about the avenues they can take to engage with Parliament and why their voices are important in the political sphere.





Pakistan

We also welcomed a delegation from the Youth Parliament of Pakistan, and a group of Malaysian young leaders, to Westminster, with topics ranging from gender equality and representation, devolution and bilateral relations.

Women in Parliament

As part of our ongoing work to support women in parliaments and advance gender-related priorities across the Commonwealth, we sent a delegation to the 2024 British Islands and Mediterranean Commonwealth Women Parliamentarians Conference in Malta, which has recently implemented a mechanism to ensure more women are elected to its parliament.

The programme was scheduled to coincide with International Women's Day which brought added pertinence and enthusiasm to discussions which focused on tackling gender inequality, increasing women's representation in



elected bodies and advocating for gender-sensitive parliaments. There was also an online session with young women from delegates' own jurisdictions who made impactful contributions on the issues most affecting them and their female compatriots.

The Gambia

Our delegation visit to The Gambia in February 2024 focused on the recently-formed gender committee, the setting up of which can in part be attributed to CPA UK's Post-Election Seminar in 2022.

Kenya

In June 2023 an all-female delegation of UK parliamentarians visited Nairobi, Kenya, and engaged with the 102-strong Kenya Women's Parliamentary Association (KEWOPA), exploring gender-based themes and building a stronger connection between women parliamentarians in the two parliaments.

Security

In a world of increasingly complex and immediate threats, the evolving role that parliaments play in tackling and anticipating national security concerns is more important than ever.

In November last year we hosted the Commonwealth Conference on Parliamentary Scrutiny and Oversight of National Security. Focusing on scrutiny and oversight, the conference explored global trends in national security, including topics such as conflict resolution and peacebuilding, cybersecurity and climate change.

Our bilateral programmes also reflected the increasing importance of international partnerships in guaranteeing collective security.



Australia

Discussions with a delegation from the Parliament of Australia in November 2023 centered around how the UK and Australia can partner to tackle common threats.

Fiji & New Zealand

Shared security concerns in the Pacific region were high on the agenda during bilateral visits to Fiji and New Zealand in June.

Public Accounts Committees and Trade Workshop

We looked at where our priority themes intersect and complement each other, which led to the organisation of our first cross-thematic Public Accounts Committees and Trade Workshop with the Parliament of Trinidad and Tobago in February 2024.

Bringing together committee chairs, members and clerks, from the UK and the Caribbean, this workshop facilitated peer-to-peer discussions on how to enhance effective scrutiny of government spending and trade policy. Delegates also strengthened their networks across the region in the areas of public financial scrutiny and trade.





Trade

At the June 2023 Women and Trade Westminster Workshop gender provided another lens through which to evaluate the role parliaments play in trade deals and scrutiny. The programme brought together women parliamentarians for a three-day Workshop designed to strengthen their knowledge of international trade and to discuss the specific impact of trade agreements on gender equality, poverty alleviation and the economic empowerment of women in the Commonwealth.

Jamaica & Canada

Trade relations with the UK were central to discussions during bilateral visits to Jamaica and Canada in 2023, with the latter set against the backdrop of ongoing trade negotiations between the UK and Canada.

Public Accounts Committees

Continuing our work to strengthen Public Accounts Committees (PACs), we co-hosted an African Regional Workshop in partnership with the National Assembly of Zambia at the end of October.

Attended by twenty-three parliamentarians and parliamentary officials from eight legislatures across Africa and the UK, the Workshop covered key topics including cross-party collaboration in a PAC context, effective questioning techniques, and preparing for committee inquiries. The Workshop was also an opportunity to build regional networks to enable ongoing peer to peer support.

CPA UK Project:

Strengthening Parliamentary Action to Address Gender-Based Violence and Modern Slavery in Supply Chains in partnership with the UK Foreign, Commonwealth and Development Office

'Strengthening Parliamentary Action to Address Gender-Based Violence and Modern Slavery in Supply Chains' is a multi-year project delivered by CPA UK. It aims to increase the ability of parliamentarians to effectively address modern slavery in supply chains and gender-based violence (GBV) and, subsequently, to bring about a reduction in forced labour and violence against women and girls (VAWG).

The project's first year ran from March 2023 to April 2024. In November 2023, CPA UK delivered an awareness-raising workshop in Nairobi which sought to increase understanding of both modern slavery in supply chains and GBV, of good practice in developing legislation to combat these issues, and to establish a strong network, connecting parliamentarians with local experts on these issues.



The workshop was attended by almost fifty parliamentarians from twelve Commonwealth legislatures. Data we collected from participants showed a 43% increase in understanding on GBV and a 26% increase on modern slavery in supply chains.

The second year of the project is now underway and we are grateful to the FCDO for their continued partnership.

Finance

CPA UK had an income of £2,907,071 which included an annual grant-inaid payment of £2,090,212 from the UK Parliament (70% House of Commons, 30% House of Lords).

The UK Overseas Territories Project received funding of £529,302 from the Foreign, Commonwealth and Development Office.

The Project on Strengthening Parliamentary Action to Address Gender-Based Violence and Modern Slavery in Supply Chains project received funding of £197,685 from the Foreign, Commonwealth and Development Office.
