# Our work with parliaments





The AI in Security Conference was delivered by CPA UK in partnership with Chatham House. The three-day programme covered the ways in which developments in artificial intelligence affect parliaments and people alike.









We brought together parliamentarians in Westminster to discuss how to strengthen laws on modern slavery in supply chains and violence against women and girls.

# Our work with parliaments

### Over 600 delegates from 64 parliaments

Over 600 Members, clerks, and parliamentary officials from 64 parliaments across the Commonwealth, Overseas Territories, Crown Dependencies and Devolved Legislatures participated in our programmes.

### 105

Members of the House of Commons and the House of Lords participated in one or more activities.

44%

Of the participants in our programmes were women.

43

# Assessing the UK's General Election

For the UK's General Election last year, CPA UK sent eight teams of Election Observers right across the country. Their mission was to independently assess the delivery of the election against international standards.

From 16 jurisdictions across the Commonwealth, 29 parliamentarians travelled to the UK to deliver this Mission. On election day, our team observed and recorded data from 263 polling stations, and in counting centres across eight constituencies.

# Assessing the UK's General Election

Observation teams went to Birmingham Ladywood, Brighton Pavilion, Bristol Central, Glasgow East, Ilford South, Liverpool Walton, North Northumberland and North West Cambridgeshire. The eight constituencies covered a broad range of demographics, geographical regions and voting patterns.

Commonwealth parliamentarian observers represented a diverse range of jurisdictions and experiences ensuring a variety of perspectives and insights. All observers undertook training before deployment to constituencies and were registered observers with the Electoral Commission.

CPA UK, in its capacity as secretariat for CPA BIMR, has delivered 25 election missions since 2011. With the exception of the UK, all missions have been in the Crown Dependencies and the UK Overseas



Territories. For every Mission, CPA UK recruits a diverse team of parliamentarians, staff, and election experts to conduct independent observations of electoral processes.

# Achievements this year

### **Building networks**

Parliamentarians from all around the Commonwealth say they benefit from our unique network and peer-to peer learning opportunities. Through us, expertise and knowledge are shared. In a recent House of Lords debate, Lord Purvis of Tweed drew attention to how we help create vital trade opportunities by bringing people together.

### Working on legislative themes

In accordance with the Commonwealth Charter, we are committed to the promotion and protection of Human Rights. Our seminar on strengthening laws around modern slavery and gender-based violence led to parliamentarians taking collective action. They signed an open letter urging leaders at the Commonwealth Heads of Government Meeting (CHOGM) in Samoa to take firmer action on forced labour and gender equality. Parliamentarians from Nigeria, The Gambia, Kenya, Malawi and St Helena have continued to push for change in these areas.

## **Achievements this year**

### Modern slavery handbook


Following an intensive period of collaboration with stakeholders CPA UK published a new handbook for parliamentarians and policy makers on Legislating Against Modern Slavery in Supply Chains. It is an invaluable

resource drawing on the expertise of over 50 authors from across the Commonwealth.

### **Observing elections**

Our election work has led to lasting change in UK Overseas Territories Turks and Caicos Islands, British Virgin Islands, Montserrat and Caymans Islands. To ensure elections are fair, transparent and accountable, these jurisdictions have implemented recommendations made by CPA British Islands and Mediterranean Region observer missions arranged by CPA UK.

# Achievements this year

### Our partnerships

Our partnerships and collaborations with FCDO, Non-Governmental Organisations, respected thinktanks and international academics place us firmly on the global stage. One example is our Al in Security Workshop held in January 2025 in partnership with Chatham House, with the Tony Blair Institute for Global Change as a contributor.

At a session she chaired on Al and elections, Dawn Butler MP set out the relevance of discussions:

### Helping to achieve status change for CPA

Last year the new UK Government brought forward legislation to change the status of the Commonwealth Parliamentary Association. This was enacted in January 2025 which means it is now recognised as an international organisation, rather than a UK charity.

CPA UK was actively involved in this change. Our previous Executive Committee, led by its then Chair Rt Hon. Dame Maria Miller, was instrumental in advocating for it. Members introduced legislation from the back benches and lobbied the UK Government, speaking in debates to support the change.

# How parliamentarians support us

We have cross-party support from across both Houses of Parliament. We appreciate the continuous backing of both the Speaker of the House of Commons, Right Hon. Sir Lindsey Hoyle MP and the Lord Speaker, Rt Hon. Lord McFall of Alcluith. Both generously give their time to support us in the UK Parliament and take a keen interest in our work to strengthen democracy across the Commonwealth.

# Moving towards our next strategy

To help us create our new strategy for 2026-2031 and to guide our continued development as an organisation, two academics are researching the way we work as well as our unique strengths.

As part of the Parliamentary Academic Fellowship Scheme, Dr Alex Prior from London South Bank University and Dr Louise Thompson from the University of Manchester have carried out rigorous and independent research over the course of a year. Their work is funded by the University of Manchester's Impact Acceleration Award and London South Bank University.

They examined our current strategy (2019-2025) and concluded that relationship building is a key pillar of our work. They also identified





specific areas for us to develop so we can stand out in an increasingly crowded and resource-intensive field. Their research focused on:

- 1. Institutional strengths and identity
- 2. A balanced and flexible approach to supporting parliaments
- 3. Reflecting critically on themes and objectives
- 4. Acknowledging, realising, and maximising impact

## **Finance**

CPA UK had an income of £3,184,622. This included an annual grant in-aid payment of £2,299,232 from the UK Parliament (70% from the House of Commons and 30% from the House of Lords).

The Foreign, Commonwealth and Development Office provided funding for two projects; the UK Overseas Territories Project which received £584,772 and the Project on Addressing Gender-Based Violence & Modern Slavery which received £228,379.

This is a summary of our financial activities, extracted from the audited accounts for the year ending 31 March 2025.
